PARENTAL INVOLVEMENT: Parents have a right, a need to know, as well as a consent to anything outside the curriculum that affects their child. Actually they need to be able to have access to the curriculum too. With all the means of communication today certainly we can use the best motivational tools, which are the parents, to help our students and guide their growth in areas that affect academics. RESIST THE LATEST FAD THEORIES: We are educating not indoctrinating our children. Things like CRT, CES and SEL or whatever name programs use, should be resisted in order for our teachers to focus on teaching. There are only so many hours in the day. The number one challenge educators are facing today is the "Covid Effect" i.e., the lack of progress that students across the state have made during the past year and a half. I know there are many people from parent organizations, churches, and civic organizations that want to be part of the solution and understand the value of education. We need to ask and ask and ask. A rigorous campaign for volunteers will produce results.	The pandemic has had a dramatic impact on our children. The biggest challenge is keeping kids healthy and in school, so that educational outcomes improve. Studies and test results show that online learning cannot replace the face-to-face interaction between students and their teachers and the social interaction that's needed between children. No one likes wearing masks but we must do whatever it takes to keep kids in school. We must also work to eliminate learning gaps resulting from the pandemic. Federal funds give Oregon City Schools the chance to improve outcomes with additional tutoring. I will also promote analytics-based long-term strategic planning and outcome measurement, so that we may improve the educational experience for our kids and their families. High-stakes tests are proving to be invalid and unfair, particularly to urban districts. Using flawed tests to justify and expand charter schools and vouchers to fund religious education erodes the ability of a typical district to focus on innovative opportunities to improve outcomes for all. At TPS we developed many transparent ways for the community to see the accomplishments of our district that do not rely solely on test scores. Our Board continues to lead across the state for an overhaul of the State report card system. We currently face the serious challenge of recovering from the pandemic. We also face the ongoing challenge of addressing the needs of the whole child. The unmet basic needs of children and their families cannot be addressed by schools alone.
